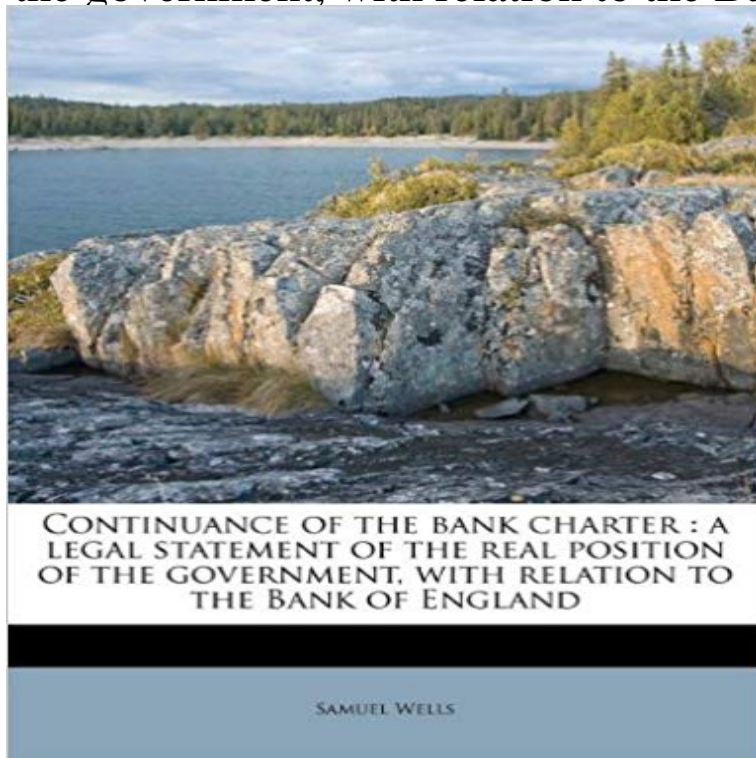


## Continuance of the bank charter: a legal statement of the real position of the government, with relation to the Bank of England
