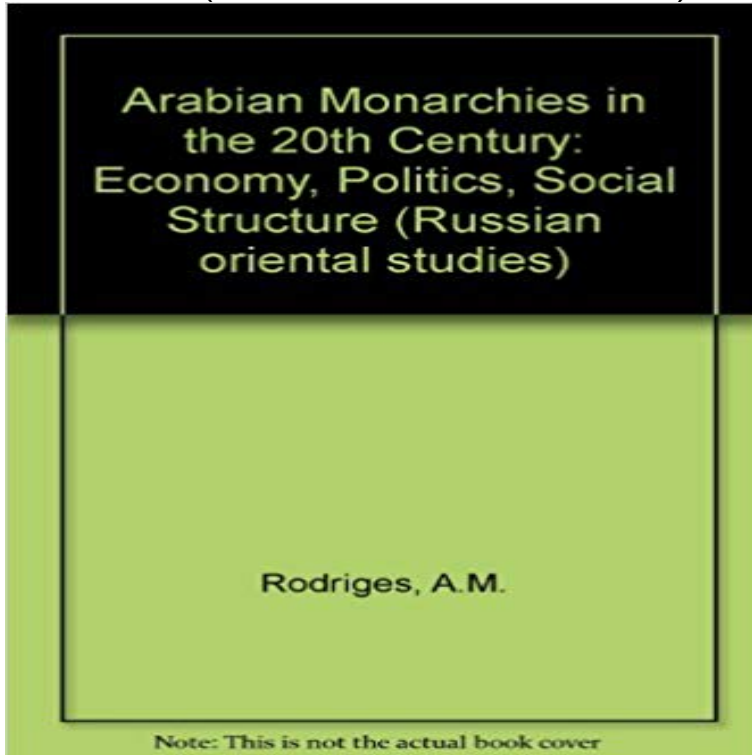


# Arabian Monarchies in the 20th Century: Economy, Politics, Social Structure (Russian oriental studies)
