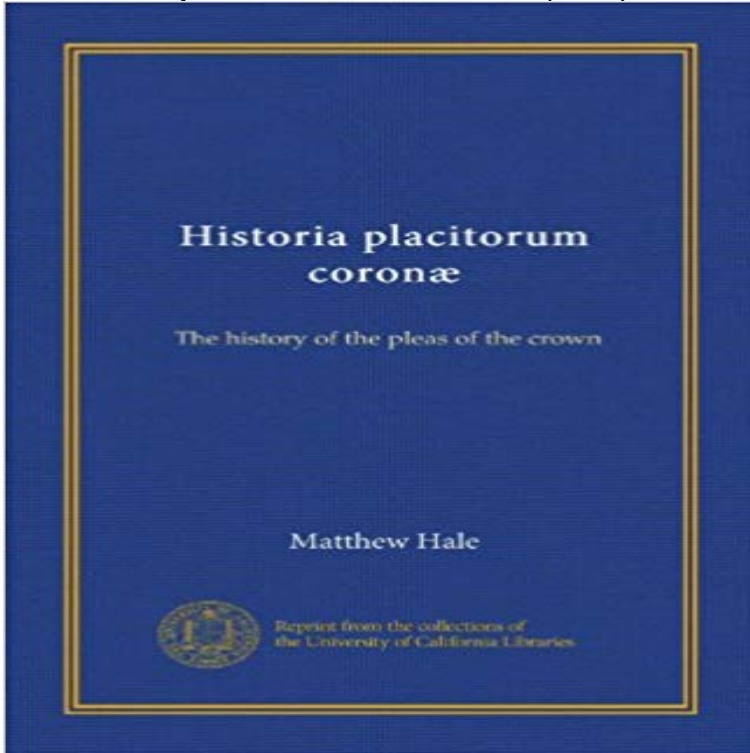


## Historia placitorum coronæ? (v.2): The history of the pleas of the crown
