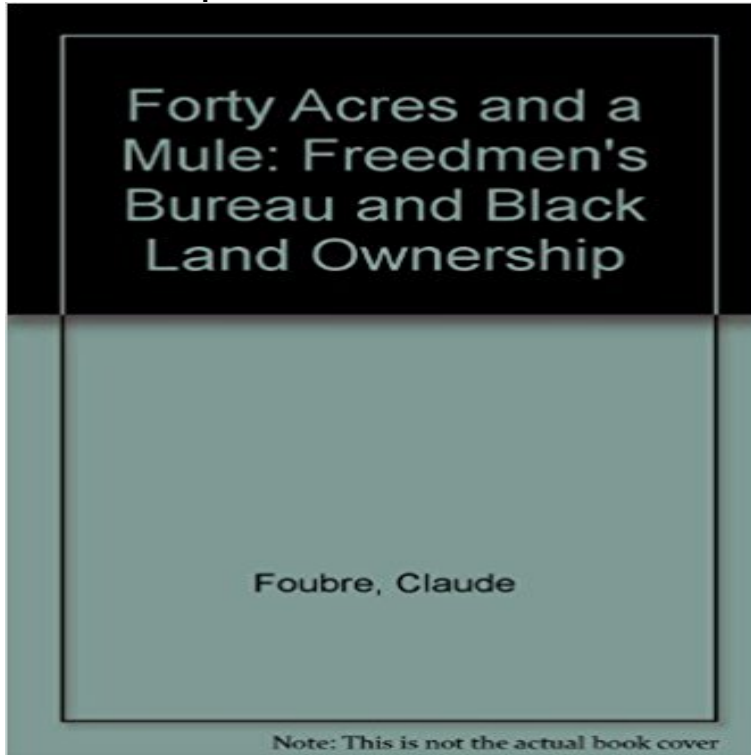


# Forty Acres and a Mule: The Freedmens Bureau and Black Land Ownership
