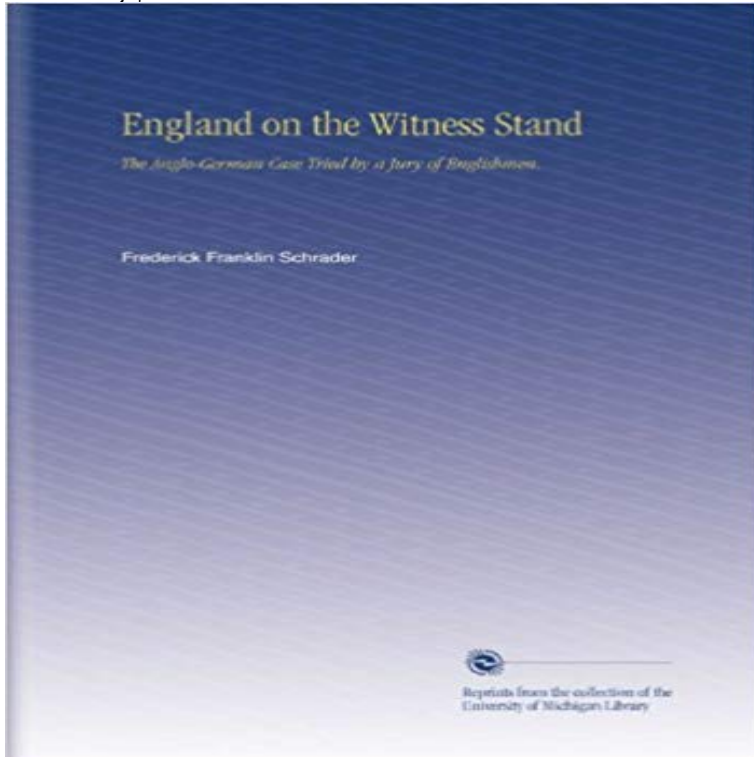


# England on the Witness Stand: The Anglo-German Case Tried by a Jury of Englishmen.
