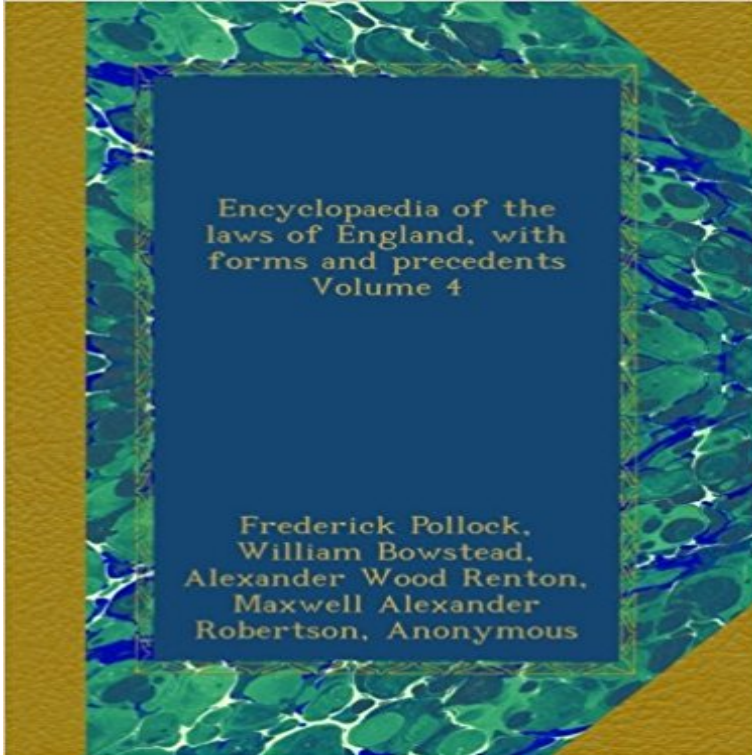


# Encyclopaedia of the laws of England, with forms and precedents Volume 4
