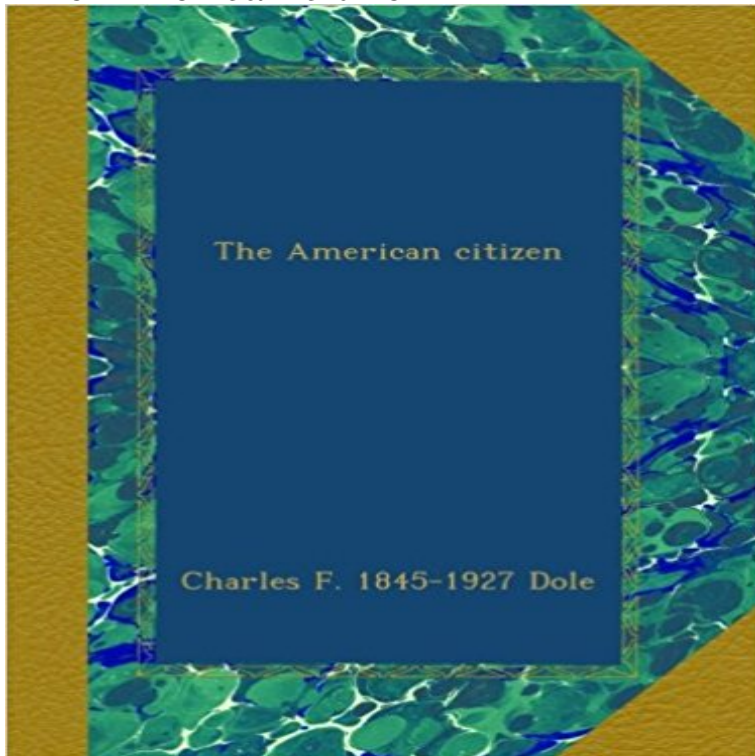


The American citizen
