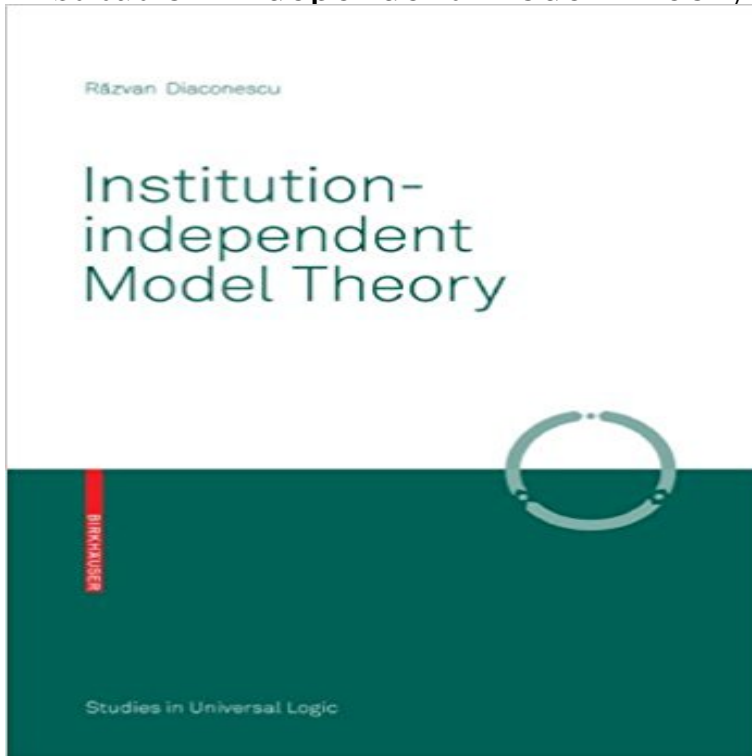


# Institution-independent Model Theory (Studies in Universal Logic)
