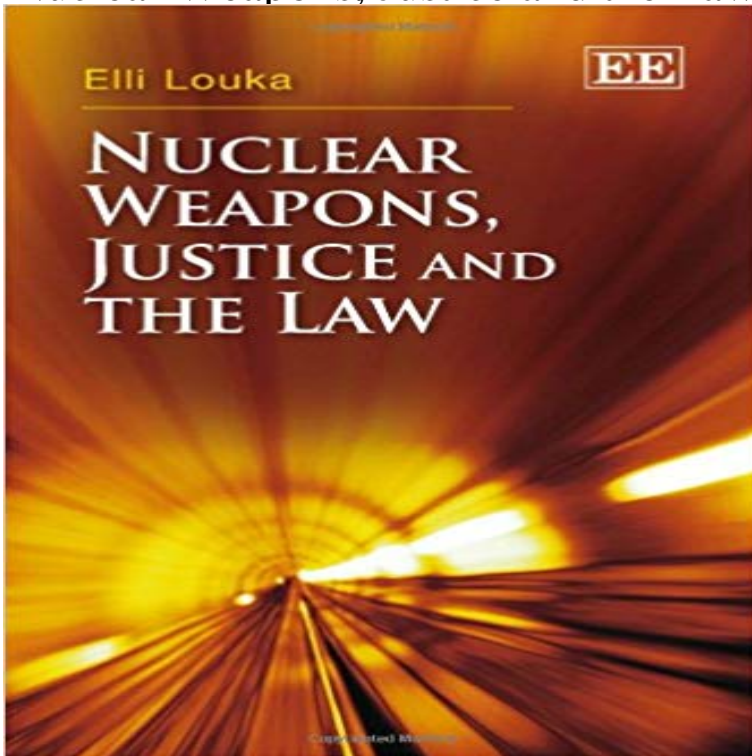


## Nuclear Weapons, Justice and the Law
