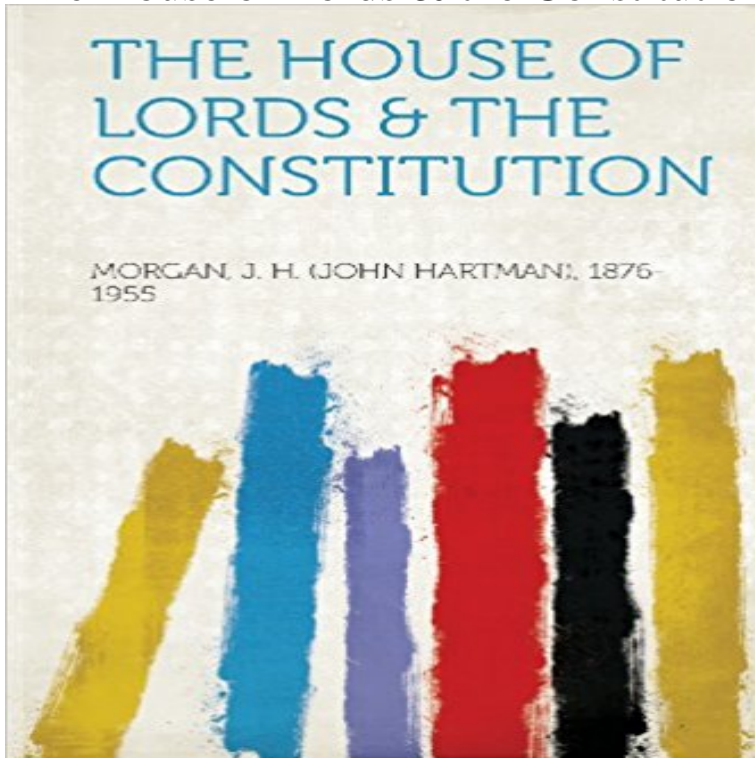


# The House of Lords & the Constitution
