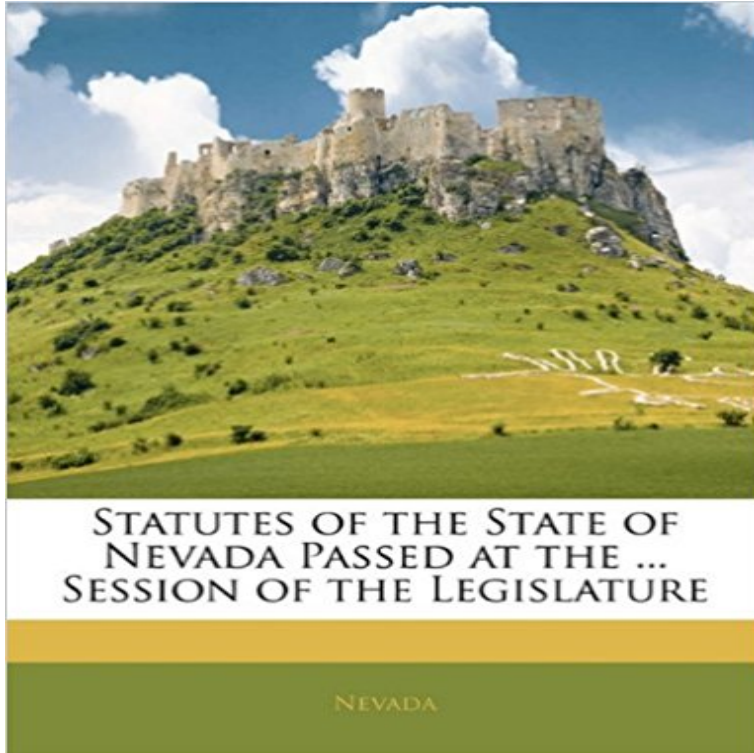


# Statutes of the State of Nevada Passed at the ... Session of the Legislature
