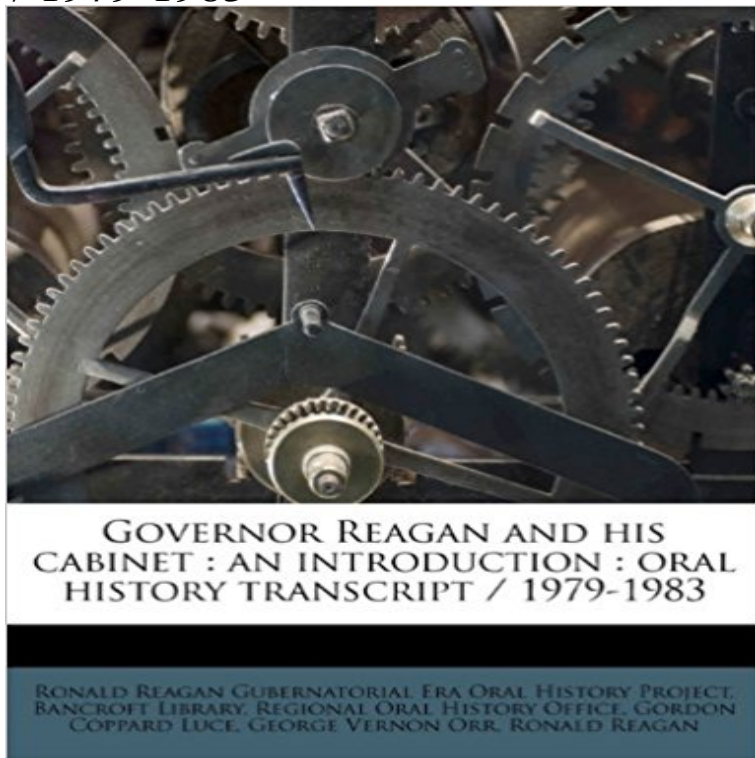


Governor Reagan and his cabinet: an introduction : oral history transcript / 1979-1983
